Sir,

In continuation of this office letter issued on 23.01.2018, you are requested ~~you~~ to incorporate the following modifications too, in the forthcoming notification for SET to be issued by you:

1. Clause of 'Conditions of Eligibility' for appearing in SET, figuring in the Notification of SET, may be modified as follows:-

*"Candidates who are pursuing their Master's degree or equivalent course OR candidates who have appeared for their qualifying Master's degree (final year) examination and whose result is still awaited or candidates whose qualifying examinations have been delayed may also apply for this test. However, such candidates will be admitted provisionally and shall be considered eligible for Assistant professor after they have passed their Master's Degree OR equivalent examination with at least 55% marks (50% marks in case of OBC falling in Non Creamy layer/SC/ST/PwD(persons with disability)) category candidates. Such candidates must complete their Master's degree or equivalent examination within two years from the date of SET result with required percentage of marks, failing which they shall be treated as disqualified."*

Other conditions of eligibility remain unchanged.

2. Since Paper-II and Paper-III have been merged, the syllabi of Paper-II and Paper-III shall now form the syllabus of Paper-II.

3. In view of merger of Paper-II and Paper-III as Paper-II now, Clauses (i) and (vi) of modified qualifying criteria of NET for Eligibility for Assistant Professor conveyed to you vide UGC letter dated 13.06.2017 & 14.06.2017, may be modified as:

i) In order to be considered for eligibility for Assistant Professor, the candidates must have appeared in both the papers and secured at least 40% aggregate marks of both the papers taken together for General Category candidates and at least 35% aggregate marks of both the papers taken together for all candidates belonging to reserved categories, viz., SC, ST, OBC (belonging to Non Creamy Layer) and PWD.

vi) The aggregate percentage of the two papers corresponding to the number of slots derived as per the previous paragraph is taken as the cut-off qualifying percentage marks for a particular subject category-wise.

In view of above, the future notification(s) of SET examination(s) already accredited by UGC, may be suitably modified.
